

Virtuoso Prize Draw ("Prize Draw")

1. The Promoter

The promoter (Virtuoso Limited of 777 Main St #900, Fort Worth, TX 76102, United States, "The Promoter") is running a Prize Draw in association with Virtuoso Agencies located in the United Kingdom and Ireland.

2. The Prize Draw

2.1 The prize of the Prize Draw is "Prize Draw £1000 travel voucher" (the "Prize"), to be spent exclusively with a Virtuoso Agency.

2.2 The Prize is supplied by the Promoter.

2.3 The purpose of this Prize Draw is to promote the Promoter's magazine ("Virtuoso Magazine") and any future marketing material.

3. How to enter

3.1 The Prize Draw will run from 09:00 on 2nd January 2026 (the "Opening Date") to midnight on 31 December 2026 (the "Closing Date") inclusive.

3.2 To enter the Prize Draw all entries must

- (a) submit the online entry form provided on [WEBSITE] by the Closing Date; and
- (b) subscribe to the Virtuoso Magazine [LINK TO SIGN UP] by providing an email address and postal code.

3.3 No purchase is necessary and there is no charge to subscribe to the Virtuoso Magazine.

3.4 All Prize Draw entries must be received by the Promoter by no later than midnight on the Closing Date. All Prize Draw entries received after the Closing Date are automatically disqualified.

3.5 The Promoter will **not** accept responsibility for Prize Draw entries that are lost, mislaid, damaged or delayed in transit, regardless of cause, including, for example, as a result of any, equipment failure, technical malfunction, systems, satellite, network, server, computer hardware or software failure of any kind.

3.6 By entering the Prize Draw, you are agreeing to be bound by these terms and conditions and the Promoter's Privacy Policy. Both can be found on the Promoter's [WEBSITE]

3.7 A winner will be selected at random from the Prize Draw entries using a data picker system on 31st January 2027 at [11:00] ("Announcement Date").

4. Eligibility

4.1 The Prize Draw is open exclusively to residents in the United Kingdom and Ireland, aged 18 years or over.

4.2 The Prize Draw is **not** open to and the Promoter will **not** accept entries which are:

- (a) made by employees of the Promoter or its holding or subsidiary companies;
- (b) made by employees of Agents/Advisors or suppliers of the Promoter or its holding or subsidiary companies, who are professionally connected with the Prize Draw or its administration;
- (c) made by members of the immediate families or households of (a) and (b) above;
- (d) automatically generated by a computer or created by artificial intelligence (including but not limited to chatbots such as ChatGPT or similar software applications);
- (e) from third parties or in bulk;
- (f) from outside the United Kingdom or Ireland;
- (g) illegible, have been altered, reconstructed, forged or tampered with; or
- (h) otherwise incomplete.

4.3 In entering the Prize Draw, you confirm that you are eligible to enter and claim the Prize. The Promoter may require you to provide proof that you are eligible to enter the Prize Draw.

4.4 There is a limit of one entry to the Prize Draw per person.

4.5 Entries on behalf of another person to the Prize Draw will not be accepted and joint submissions to the Prize Draw are not allowed.

4.6 The Promoter reserves all rights to disqualify any Prize Draw entries if conduct in relation to the Prize Draw is contrary to the spirit or intention of the Prize Draw.

5. The Prize

5.1 There is one (1) Prize of a £1000 travel voucher to be spent exclusively with a Virtuoso Agency.

5.2 The Prize may be used as partial payment towards travel arrangements, purchased exclusively with a Virtuoso Agency.

5.3 The Promoter reserves the right to substitute the Prize with an item of equal or greater value if circumstances beyond the Promoter's control makes it necessary to do so.

5.4 The Prize is not negotiable or transferable.

6. Winners

- 6.1 The Promoter will contact the winner personally as soon as practicable after the Announcement Date, using the email address provided with the Prize Draw entry.
- 6.2 The Promoter must either publish or make available information that indicates that a valid award took place. To comply with this obligation the Promoter will send the surname and county of the Prize winner and, within one month after the Closing Date of the Prize Draw.
- 6.3 If you object to any or all of your surname, county and winning entry being published or made available, please contact Thomas Ricketts at tricketts@virtuoso.com. In such circumstances, the Promoter must still provide the information and winning entry to the Advertising Standards Authority on request.

7. Claiming the Prize

- 7.1 If you are the winner of the Prize, the Promoter will contact you as per clause 6.1 above and you:
- (a) must respond to the Promoter by email, acknowledging receipt of such notification by the Promoter within [6] days of receipt; and
 - (b) will have [365] of days from the Announcement Date to spend the Prize with your Virtuoso Advisor/Agency. If you do not spend the Prize by this date, your Prize will expire.
- 7.2 The Prize may not be claimed by a third party on your behalf.
- 7.3 The Promoter will make all reasonable efforts to contact the winner. If the winner cannot be contacted or is not available, or has not claimed their Prize within [7] days of the Announcement Date, the Promoter reserves the right to offer the Prize to the next eligible entrant selected from the correct entries that were received before the Closing Date.
- 7.4 The Promoter does not accept any responsibility if you are not able to take up the Prize.

8. Limitation of liability

Insofar as is permitted by law, the Promoter, its agents or distributors will not in any circumstances be responsible or liable to compensate the winner or accept any liability for any loss, damage, personal injury or death occurring as a result of taking up the Prize except where it is caused by the negligence of the Promoter, its agents or distributors or that of their employees. Your statutory rights are not affected.

9. Ownership of Prize Draw entries and intellectual property rights

- 9.1 The Promoter does not claim any rights of ownership in your Prize Draw entry.
- 9.2 You agree that the Promoter may, in their sole discretion, make your entry available on its website www.virtuoso.com and in any other media, whether now known or invented in the future, and in connection

with any publicity of the Prize Draw. You grant the Promoter a non-exclusive, worldwide, irrevocable licence in perpetuity, for the full period of the intellectual property rights in the Prize Draw entry, to use, display, publish, transmit, copy, edit, alter, store, re-format and sub-licence the intellectual property rights in the Prize Draw entry.

10. Data protection and publicity

10.1 The Promoter will only process your personal information as set out in the [\[LINK TO PRIVACY POLICY\]](#). See also condition 6.2 and condition 6.3, with regard to the announcement of winners.

11. General

11.1 If there is any reason to believe that there has been a breach of these terms and conditions, the Promoter may, at its sole discretion, reserve the right to exclude any entry from participating in the Prize Draw.

11.2 The Promoter reserves the right to hold void, suspend, cancel, or amend the Prize where it becomes necessary to do so.

11.3 These terms and conditions are governed by English law. If any entrants to this Prize Draw wish to take court proceedings, then they must do this within the courts in the United Kingdom.
